The Homeless Court Pop-up Resource Fairs are available throughout San Diego County on a rotating basis to provide a one-stop resource fair, with the added ability to clear traditional legal barriers to those services on site.

HCP Pop-Up Fairs are walk up events that provide direct access to the Homeless Court Program, State Services & Benefits, and Community-Based Organizations. Participation in HCP typically requires a referral from an approved HCP Provider, but no referral is required for this event.
